## The Michael Minger Act Report for 2012 Activity Reported for Calendar Year 2011

### Section 1: Campus Security Authority

*List campus security authority personnel (definition at KRS 164.948(2)):*

Campus security personnel at the Maysville Community and Technical College-Rowan Campus are: Branch Campus Director, Coordinator of Academic Programs, Safety Coordinator, Director of Maintenance and Operation, Maintenance and Operations personnel, and any faculty or staff person that may be present. The Director of Maintenance and Operations serves as overall security coordinator for all campuses of the college.

*Describe the extent and nature of enforcement authority of campus security authority personnel:*

Campus security authority personnel have no arrest or police powers and cooperate fully with local and state police authorities who investigate campus incidents as part of their area of jurisdiction.

*Describe the working relationship of campus security authority personnel with state and local police agencies:*

Direct communications are maintained with the Kentucky State Police and Sherriff's office.

## **Section 2: Description of Information Programs**

*Describe programs that inform students and employees about:*

*(a) Campus safety and security*

Employees are informed about safety and security during initial orientation and periodically during faculty and staff meetings. Students are informed about safety and security during initial orientation and by faculty during classroom orientation. The Rowan Campus Crisis Management Plan is posted on the college intranet.

*(b) How to report a crime:*

Employees and students are informed about reporting crimes during orientation. Campus security authority personnel are available during normal hours of operation to respond to any complaints or crime reports. Complaints that cannot be handled by these people will be referred to the local police agency.

*(c) How to prevent crimes:*

Orientations conducted during initial processing and by individual faculty members, inform students on crime prevention.

### **Section 3: Statements of Policies and Procedures**

*(a) Provide the institution's policy statement on making Special Reports to the campus community of crimes that present a safety or security threat to students or employees. KRS 164.9481(d)*

In all cases of crimes against persons, consideration shall be as to whether other members of the community may be at risk if the perpetrator remains at large. Initially the Branch Campus Director may make the required determination if a campus-wide alert is obviously necessary. In cases where doubt exists, an Ad Hoc committee, comprised of the College President, Branch Campus director, Coordinator of Academic Programs, Director of Maintenance and Operation, Safety Coordinator and shall convene to determine the need for a "crime alert," its content, the type, and extent of media release. In the event that not all committee members are immediately available, any number of those available will make the decision and draft a release with advice and input from the Director of Public Relations and KCTCS.

Types of releases are:

- a. Posted notices throughout the campus in public areas.
- b. Posted on the College web page at <http://maysville.kctcs.edu>.
- c. Voice mail bulletins.
- d. Email bulletins.
- e. Public media releases made via the office of Public Relations.
- f. Any or all notifications listed above.

As a general rule, committee members will decide in favor of the safety and wellbeing of the campus community. When in doubt, a "crime alert" will be issued.

*(b) If the institution provides student housing facilities, describe the institution's procedure for disclosing the existence or nonexistence of automatic fire suppression systems in on-campus housing facilities. KRS 164.9492*
